Terms and Conditions of Entry:

1. Entrants are required to design an original outfit according to the brief.
2. Designer does not have to be the maker of the outfit.
3. A photograph of how the finished garments are to be worn must accompany the entry if selected as a finalist.
4. The outfit must not have been placed or won any other competition.
5. Designer of outfit must not be designing and trading as a brand commercially.
6. All Entries must be well and securely labeled with designers full name, and not visible when modeled.
7. Once outfits are in the hands of the organisers they cannot be uplifted until released by the organisers.
8. It is the responsibility of entrants to insure their property from the time of initial dispatch through to it's ultimate return. The organisers take no responsibility for garments lost in transit. Please use reliable couriers (recommended for P.O Box - Courier Post) and make sure the return address is correct.
9. Cost of all postage and packaging is the responsibility of the entrant. Outfits must be boxed for postage/freight. Return address and name clearly marked.
10. Organisers reserve the right to use outfits for further promotion and display purposes, you will be informed following conclusion of the event if this applies to you.
11. If outfits are not received by 5pm on Wednesday 12 October 2011 they will be disqualified.
12. By entering this competition, the entrant declares all details true and correct.
